**AGREED ORDER ABATING THE PALM BEACH FINANCE II, L.P. LIQUIDATING
TRUST MONITOR’S ROLE, PENDING THE APPROVAL OF SETTLEMENTS
INVOLVING THE TRUST MONITOR**

THIS CAUSE came before the Court upon an Agreed Exparte Motion For Abatement of Palm Beach Finance II, L.P. Liquidating Trust Monitor’s Role, Pending The Approval Of Settlements Involving The Trust Monitor [ECF No. 3535] (“Motion”). The Court, having

reviewed the Motion, being advised that the PBF Liquidating Trustee consents to the relief requested in the Motion and being otherwise duly advised in the premises, hereby:

ORDERS as follows:

1. The Motion is GRANTED.
2. Geoffrey Varga's role as the Liquidating Trust Monitor for the Palm Beach Finance II, L.P. Liquidating Trust ("Trust Monitor") shall be abated, pending this Court's approval of the PBF/Offshore Settlement (as defined in the Motion) and the Minnesota Bankruptcy Court's approval of the PCI/Offshore Settlement (as defined in the Motion). Accordingly, Mr. Varga's duties and obligations as Trust Monitor, as well as the PBF Liquidating Trustee's obligation to consult and obtain agreement from Mr. Varga as Trust Monitor, shall cease during the interim period until this Court and the Minnesota Bankruptcy Court approve the aforementioned settlement agreements.
3. In the interim period prior to said Court approvals, all rights and claims by the PBF Liquidating Trustee and the Trust Monitor shall be preserved.
