Application

Mr. Brett A. Stillman (“**Mr. Stillman**”) and PC Doctor, LLC, (“**PC Doctor**” and collectively with Mr. Stillman, the “**Applicant**”), having been approved by this Court as consultants for the Chapter 11 Liquidating Trustee, Barry E. Mukamal (“**Trustee**”), applies for reimbursement of expenses and for professional services rendered by Applicant in this Chapter 11 proceeding between March 1, 2023 through October 31, 2024. This application is filed pursuant to 11 U.S.C. §§ 330 and 331 and Bankruptcy Rule 2016, and meets all of the requirements set forth in the Guidelines incorporated in Local Rule 2016-1(B)(1). The exhibits attached to this application, pursuant to the Guidelines, are:

Exhibits “1” - Fee Application Summary Chart;

Exhibit “2A” and “2B” - Summary of Professional and Paraprofessional Time;

Exhibit “3” – Summary of Requested Reimbursements of Expenses; and

Exhibit “4” – The Applicant's complete time records, in chronological order, by activity code category, for the time period covered by this application. The requested fees are itemized to the tenth of an hour.

Background

1. On November 30, 2009, Palm Beach Finance Partners, L.P. (together with Palm Beach Finance II, L.P., the “**Debtors**”) filed its Voluntary Petition for relief under chapter 11 of the United States Bankruptcy Code [ECF No. 1]. On December 1, 2009, this case was jointly administered with the estate of *In re: Palm Beach Finance II, L.P.*, Case No. 09-36396-PGH [ECF No. 19].

2. On January 28, 2010, the Court entered the Agreed Order Directing Appointment of Chapter 11 Trustee and denying the United States Trustee’s Motion to Convert Cases to Cases under Chapter 7 [ECF No. 100].

3. On January 29, 2010, the United States Trustee appointed the Liquidating Trustee

as Trustee in both estates [ECF No. 107].

4. On October 17, 2013, this Court entered an Order [ECF No. 1997] granting the Liquidating Trustee's Motion to Amend: (i) the Employment Application of Brett A. Stillman and PC Doctor, LLC; and (ii) Order Authorizing the Employment and Retention of Brett A. Stillman and PC Doctor, LLC [ECF Nos. 1845 and 1863] as a consultant for the Liquidating Trustee, *nunc pro tunc* to May 21, 2013.

5. At the confirmation hearing held on October 19, 2010, the Court confirmed the Second Amended Joint Plan of Liquidation of Barry Mukamal, as Chapter 11 Trustee of Palm Beach Finance Partners, L.P. and Palm Beach Finance II, L.P. and Geoffrey Varga, as Joint Official Liquidator of Palm Beach Offshore, Ltd. and Palm Beach Offshore II, Ltd., dated September 3, 2010 [ECF No. 245] ("**Plan**") in the above referenced jointly administered bankruptcy proceeding. The Plan defines Confirmation Date as "the date on which the Bankruptcy Court enters the Confirmation Order on its docket." The Order Confirming Second Amended Joint Liquidating Chapter 11 Plan [ECF No. 444] ("**Confirmation Order**") was entered on the Court's docket on October 21, 2010.

6. Article 7 of the Plan provides in pertinent part:

7.1.4 *PBF Liquidating Trust Management.* Barry Mukamal shall be PBF Liquidating Trustee with the power and authority set forth in the PBF Liquidating Trust Agreement.

7.1.5 *PBF Liquidating Trust Structure.* As more fully set forth in the PBF Liquidating Trust Agreement, the PBF Liquidating Trustee shall oversee and direct the PBF Liquidating Trust's operations and activities, including the retention of counsel.

7.1.7 *PBF II Liquidating Trust Monitor.* Geoffrey Varga, as Joint Official Liquidator for Offshore Funds shall be the PBF II Liquidating Trust Monitor with the power and authority set forth in the PBF II Liquidating Trust Agreement.

7.1.11 Compensation of Professionals Retained by the Liquidating Trustees and the PBF II Liquidating Trust Monitor. Professionals retained by the PBF II Liquidating Trust Monitor and the Liquidating Trustee shall be entitled to monthly interim compensation for fees and expenses incurred in carrying out their duties consistent with the Plan and the Liquidating Trust Agreements; provided, however, that the PBF II Liquidating Trust Monitor or the Liquidating Trustee shall provide to the other, and the United States Trustee, notice of such requested fees and expenses on a monthly basis. Following such notice, if no objections to the fees and expenses set forth in the monthly statement are received in writing within 10 business days, 100% of such professional's fees and expenses shall be paid. Notice of objections to such fees and expenses shall be made via e-mail and/or facsimile. If objections to the fees and expenses are made and cannot be resolved, such objections will be heard and resolved by the Bankruptcy Court. Any such fees and expenses shall be payable from the Trust Asset of the Liquidating Trusts. The PBF II Liquidating Trust Monitor and the Liquidating Trustee shall, no less frequently than once every four (4) months, submit applications to the Bankruptcy Court for final approval of reimbursement of fees and expenses paid to their professionals.

7. This application is submitted for the allowance and payment to Applicant in the amount of \$4,500 for costs incurred between March 1, 2023 and October 31, 2024, for a total request of \$4,500.

8. All of the services rendered by Applicant were performed for and on behalf of the Liquidating Trustee.

Summary of Services Rendered

9. Applicant rendered varied services on behalf of the Liquidating Trustee for the period of time from March 1, 2023 and October 31, 2024. Applicant is requesting \$4,500 in costs for providing services including the storage of forensic evidence.

10. Applicant believes that the requested expenses of \$4,500 is reasonable considering the nature, extent, and the value of such services, taking into account all relevant factors, including:

The time spent on such services.

11. The invoices containing the expenses incurred by Applicant are attached as Exhibit 4.

The rates charged for such services.

12. The rate charged is Applicant's customary rate for services of the type rendered herein.

13. The Applicant represents that the rates are in conformity with the fees/costs allowed in similar proceedings for similar services rendered and results obtained. Applicant respectfully requests that the Court take notice of the awards which have been made in similar proceedings.

Whether the services were necessary to the administration of, or beneficial at the time at which the service was rendered toward the completion of the case.

14. Applicant was retained by the Liquidating Trustee to advise the Liquidating Trustee with respect to electronic discovery issues for litigation in various adversary proceedings, as well as any other related task that the Liquidating Trustee has requested. The services provided by Applicant were necessary to the administration of, and beneficial to the estates at the time at which the services were rendered as well as towards the completion of the case.

Whether the services were performed within a reasonable amount of time commensurate with the complexity, importance, and nature of the problem, issue, or task addressed.

15. Applicant submits that the services were performed within a reasonable amount of time commensurate with the complexity, importance, and nature of the problem, issue and tasks addressed.

With respect to a professional person, whether the person is board certified or otherwise has demonstrated skill and experience in the bankruptcy field.

16. Applicant has substantial experience in the areas of information technology consulting for hardware, software, networking, network security, virtualization, data communication, disaster recovery, computer forensics and electronic discovery management. The quality of work performed by Applicant in this proceeding attests to Mr. Stillman's experience, reputation and ability.

17. A copy of Mr. Stillman's curriculum vitae is attached to the Liquidating Trustee's Application to Employ Brett A. Stillman and PC Doctor, LLC. [ECF No. 1845], and is incorporated herein by reference.

Whether the compensation is reasonable based on the customary compensation charged by comparably skilled practitioners in cases other than cases under title 11.

18. The amount requested by Applicant is reasonable in terms of awards in cases of similar magnitude and complexity. The compensation which Applicant is requesting comports with the mandate of the Bankruptcy Code, which directs that services be evaluated in light of comparable services performed in non-bankruptcy cases in the community. The expenses requested by Applicant in the amount of \$4,500 is entirely appropriate.

19. Applicant considers the reasonable value of services rendered to this estate to be not less than \$4,500 for services rendered in the application period.

Allocation Between Debtors' Estates

20. The Liquidating Trustee requests that 18% of the fee awarded be allocated to Palm Beach Finance Partners, L.P. ("**PBF**") and 82% of the fee awarded be allocated to Palm Beach Finance II, L.P. ("**PBF II**"). Section 1.76, entitled "Pro Rata Allocation Formula," of the Second Amended Joint Plan of Liquidation dated September 3, 2010 [ECF No. 245] provides for

a *pro rata* allocation formula derived from the Compiled Financial Statements, dated April 30, 2008, for each of the Debtors by Kaufman Rossin & Co. The data contained therein supports an 18%/82% allocation between PBF and PBF II, respectively, based upon the total assets of each entity as of the date of such compilations. Based on the circumstances and since the services provided by APPLICANT were performed on behalf of and benefitted both estates, the Liquidating Trustee believes that this formula is the proper methodology to allocate certain fees and expenses between the two estates and respectfully requests the Court approve the allocation of expenses requested in this Application as follows:

Request for Final Approval

21. Pursuant to Article 7.1.11 of the Plan: “The PBF II Liquidating Trust Monitor and the Liquidating Trustee shall, no less frequently than once every four (4) months, submit applications to the Bankruptcy Court for final approval of reimbursement of fees and expenses paid to their professionals.”

WHEREFORE, Applicant respectfully requests that it be allowed the full reimbursement of expenses sought under this application as a final award. Applicant requests this Court (i) to award a total of \$4,500 for expenses incurred between March 1, 2023 and October 31, 2024; (ii) to approve the allocation of expenses between the estates; and (iii) for such other and further relief this Court deems just and proper.

CERTIFICATION

1. I have been designated by PC Doctor, LLC, ("***Applicant***") as the professional with responsibility in this case for compliance with the "Guidelines for Fee Applications for Professionals in the Southern District of Florida in Bankruptcy Cases" ("***Guidelines***").

2. I have read the Applicant's application for compensation and reimbursement of expenses ("***Application***"). The application complies with the Guidelines, and the fees and expenses sought fall within the Guidelines, except as specifically noted in this certification and described in the application.

3. The fees and expenses sought are billed at rates and in accordance with practices customarily employed by the Applicant and generally accepted by the Applicant's clients.

4. In seeking reimbursement for the expenditures described on Exhibit 4, the Applicant is seeking reimbursement only for the actual expenditure and has not marked up the actual cost to provide a profit or to recover the amortized cost of investment in staff time or equipment or capital outlay (except to the extent that the Applicant has elected to charge for in-house photocopies and outgoing facsimile transmissions at the maximum rates permitted by the Guidelines).

5. In seeking reimbursement for any service provided by a third party, the Applicant is seeking reimbursement only for the amount actually paid by the Applicant to the third party.

6. The following are the variances with the provisions of the Guidelines, the date of each court order approving the variance, and the justification for the variance: none.
