TRUSTEE'S APPLICATION FOR EMPLOYMENT OF BARRY E. MUKAMAL, CPA AND KAPILAMUKAMAL, LLP AS ACCOUNTANTS AND ADVISORS NUNC PRO TUNC TO MAY 1, 2014

Barry E. Mukamal, as Trustee for the estate of the above-captioned Debtor (the "Trustee"), applies to the court for authorization and approval of the employment of Barry E. Mukamal, CPA ("Mukamal") and the accounting firm of KapilaMukamal, LLP ("KM") as accountants and advisors for the Trustee and the estate, *nunc pro tunc* to May 1, 2014, and respectfully represents:

- 1. The undersigned is the duly appointed, qualified and acting Liquidating Trustee in this case.
- 2. In order for the Trustee to properly discharge his duties in this case, it is essential that he employ accountants and advisors to assist him in tax compliance filings and other financial matters, including litigation support. The Trustee has selected KM because of its extensive experience and expertise in bankruptcy and related matters.
- 3. Barry E. Mukamal, CPA and Soneet Kapila, CPA are both partners of the firm KapilaMukamal LLP ("KM") and both serve as members of the Chapter 7 Panel of Trustee's in the Southern District of Florida.
- 4. On February 17, 2010, the Trustee filed his Application to Employ Forensic Accountants and Advisors *Nunc Pro Tunc* to February 8, 2010 (ECF #124) seeking to employ

Barry E. Mukamal, CPA and Marcum, LLP ("Marcum") and the Order approving the application was entered on February 18, 2010 (ECF #125).

- 5. Marcum's employment in this case shall continue for on-going and discrete matters. Marcum shall continue to provide analysis of cash transfers and transactions relating to litigation in process. Since Marcum has generated spreadsheets containing details of specific transactions requested by Trustee's counsel during litigation, the Trustee determined that the Estate would be best served by Marcum providing analysis of source transaction in support of counsel's efforts.
- I am a retired partner of the accounting firm of Marcum, LLP as of May 1, 2014. On
 May 1, 2014, Soneet Kapila and I formed Kapila Mukamal, LLP an accounting and litigation support firm.
- 7. Under the retirement agreement between Marcum and myself, there are continuing benefits and obligations between the parties to that agreement, including my receiving compensation for services rendered by Marcum on and after May 1, 2014 on certain of those files I originated where Marcum continues to provide services.
- 8. I do not believe that this arrangement is a violation of Section 504 of the Bankruptcy Code. Section 504 provides in general that a person receiving compensation or reimbursement under Section 503(b)(2) or 503(b)(4) may not share or agree to share any compensation unless it is with another member, partner or regular associate in such association corporation or partnership. I believe that my retired partner status qualifies under the exception to Section 504.
- 9. On November 7, 2012, this Court entered its Order on Application to Employ Soneet R. Kapila ("SRK") and Kapila & Company, approving SRK's employment and the employment of Kapila & Company ("KCO"), effective October 12, 2012 [ECF 1504], as experts for the Liquidating Trustee consistent with the Trustee's obligations as are set forth in 11 U.S.C. §327. KCO ceased operations as of April 30, 2014, and SKR is an equity partner in KM. KCO will file

a final fee application for services rendered through April 30, 2014. Effective May 1, 2014, the services of KCO shall transition over to KM, which will not include expert testimony.

- 10. There will be no duplication of these tasks by KM and any tasks KM will provide will not be duplicative of any work/analysis performed by Marcum.
- 11. The Trustee will routinely monitor the tasks assigned to each firm to ensure no duplication of services provided and will provide detailed instructions with respect to work flow assignments.
- 12. The Trustee shall provide a semi-annual report to the United States Trustee's office as to the status of the case and the engagement so long as both firms are providing accounting services.
- 13. The Trustee seeks to employ KM to render the following professional services to the Trustee:
- (a) review of all financial information prepared by the Debtor or its accountants, including but not limited to a review of the Debtor's financial information as of the date of the filing of the petition, its assets and liabilities, and its secured and unsecured creditors;
- (b) review and analysis of the organizational structure of and financial interrelationships among the Debtor and its affiliates and insiders, including a review of the books of such companies or persons as may be requested;
- (c) review and analysis of transfers to and from the Debtor to third parties, both pre-petition and post-petition, unrelated to the analysis being performed by Marcum, LLP;
- (d) attendance at meetings with the Debtor, its creditors, the attorneys of such parties, and with federal, state, and local tax authorities, if requested;
- (e) review of the books and records of the Debtor for potential preference payments, fraudulent transfers, or any other matters that the Trustee may request;
- (f) the rendering of such other assistance in the nature of accounting services, financial consulting, valuation issues, or other financial projects as the Trustee may deem

necessary, including but not limited to financial assistance with matters pertaining to the estate's

involvement with the creditor's commitees.

(g) preparation of estate tax returns,

(h) and any other items reasonably related to the above at the request of the

Trustee,

(i) continuation of financial analysis to assist expert, to be retained by the estate

for insolvency opinions and testimony, if needed.

14. KM neither holds nor represents any interest adverse to the estate in the matters

upon which it is to be employed, is a "disinterested person" as that term is defined by 11 U.S.C.

SS 101 (14) and 327 (a) and (d), and its employment would be in the best interest of the estate

and its creditors. An affidavit in support of this application is attached hereto as Exhibit A.

15. KM has agreed to perform the foregoing services at the ordinary and usual hourly

billing rates of its members who will perform services in this matter. KM will incur out-of-pocket

disbursements in the rendition of the services for which it shall seek reimbursement. KM

recognizes that its compensation is subject to approval and adjustment by the Court in

accordance with 11 U.S.C. §330.

WHEREFORE, the Trustee respectfully requests that this Court enter an order

approving the selection and employment by the Trustee of Barry E. Mukamal, CPA and

KapilaMukamal LLP as his accountants and advisors to perform the services set forth in this

Application, upon the terms and conditions set forth herein.

- 1. I am a Certified Public Accountant, experienced in rendering accounting, advisory, and litigation consulting services.

- g. Effective May 1, 2014, the expert services of KCO shall transition over to KM, which will not include expert testimony.
- 6. As part of its diverse practice, KM appears in cases, proceedings, and transactions involving many different creditors, shareholders, attorneys, accountants, financial consultants, investment bankers, and other entities, some of which may be or may represent claimants and parties in interest in this case. KM has a widespread practice in insolvency and bankruptcy matters and I and the Firm participate in numerous cases in both the federal and state courts

involving different professionals, including attorneys, accountants and financial consultants. Some of those professionals may represent parties-in-interest in this case. However, I am not advising any such entity and/or professional in connection with this Liquidating Trust proceeding nor do I have a relationship with any such entity or professional which is adverse to the Debtor, its creditors or the estate.

- 7. KM is otherwise well-qualified to serve as accountants for the Trustee for the purpose required. - 9. In the normal course of business, the firm has completed a conflict check containing a list of all creditors resulting in no verified conflicts.
