**ORDER AWARDING LIQUIDATING TRUSTEE'S
TWELFTH POST CONFIRMATION APPLICATION FOR COMPENSATION**

THIS CAUSE came before the Court on January 28, 2026 at 1:30 p.m., upon the Liquidating Trustee's Twelfth Post Confirmation Application for Compensation [Dkt. No. 4055] (the "*Application*").

The Court, having reviewed the Application, having heard from all parties in interest who had an opportunity to be heard, having taken into consideration 11 U.S.C. §§ 326(a), 330 and

331 and each of the factors that govern the reasonableness of fees, having heard the argument of counsel, and based on the record, it is

ORDERED as follows:

1. The Application is **APPROVED**.
2. Barry E. Mukamal, Liquidating Trustee², is awarded compensation in the amount of **\$19,105.67** (representing 100% of the fees requested) and **\$0.00** (representing 100% of expenses requested) (“*Fee and Cost Award*”).
3. The Fee and Cost Award shall be paid by the particular Trust as follows:
