Mukamal, in his capacity as Liquidating Trustee for the Palm Beach Finance Partners Liquidating Trust and the Palm Beach Finance II Liquidating Trust (the "*Plaintiff*"), pursuant to *Fed. R. Civ. P.* 55, made applicable to this Adversary Proceeding by *Fed. R. Bankr. P.* 7055 and Bankruptcy Local Rule 7055-1, following the entry of a Clerk's Default against Defendant Greater Resource Development, LLC (the "*Defendant*") [ECF No. 16] in this Adversary Proceeding. The Court having reviewed the Motion and the Court file, and having entered a separate Order granting the Motion, it is

ORDERED as follows:

1. Final Judgment is entered in favor of the Plaintiff and against the Defendant for the total sum of \$164,900.00, which amount shall bear interest from this date forward at the prevailing legal rate of interest, for which let execution issue forthwith.

2. The Court reserves jurisdiction to enter any further orders or take any other actions that may be necessary in connection with this matter, including but not limited to, the issuance of writs of execution.
