**NOTICE OF FILING AUCTIONEER'S REPORT OF SALE**

Barry E. Mukamal, in his capacity as liquidating trustee ("*Liquidating Trustee*") for the Palm Beach Finance Partners Liquidating Trust and the Palm Beach Finance Partners II Liquidating Trust (collectively, the "*Palm Beach Liquidating Trusts*"), by and through undersigned counsel, files this Auctioneer's Report of Sale in connection with the private sale of a vessel authorized by prior order of the Court (the "*Sale*"):

1. On September 13, 2011, this Court entered its *Order Granting Liquidating Trustee's Ex Parte Application to Employ Eric Rubin and Moecker Auctions, Inc. as Auctioneer* [ECF No. 758] (the "*Retention Order*").
2. Pursuant to the Retention Order, Moecker Auctions, Inc. (the "*Auctioneer*") was retained to conduct a sale and/or auction of a 2006 Sea Ray 290 SLX (the "*Vessel*").
3. In accordance with the Retention Order, the Auctioneer successfully negotiated a private sale of the Vessel (the "*Sale*").
4. On April 12, 2012, the Court entered its *Order Approving Liquidating Trustee's Motion For Entry Of Order Approving (I) Private Sale And Transfer Of Vessel To Jeffrey J. Nuccitelli Free And Clear Of Liens, Claims, And Encumbrances; And (II) Payment Of Contingency Fee* [ECF No. 1184] (the "*Sale Order*").

5. Attached hereto as Composite Exhibit "A" is a copy of the Auctioneer's Report, including an expense breakdown and copies of vendor invoices, detailing the costs and expenses incurred by the Auctioneer in connection with the Sale.

6. The total proceeds realized from the Sale are \$44,750.00.

7. The expenses incurred and to be reimbursed to the Auctioneer total \$9,486.10 (the "*Expenses*"), and include \$2,773.60 in out-of-pocket expenses and a 15% commission in the amount of \$6,712.50, as authorized pursuant to the Retention Order.

8. In accordance with the Retention Order, any objections to the Expenses must be filed in writing within 10 days of the service of this Notice of Filing Auctioneer's Report of Sale. Absent any such objection being filed, the Expenses shall be paid without the necessity of further notice or hearing.
