**ORDER AWARDING FINAL POST CONFIRMATION FEE  
APPLICATION FOR ALLOWANCE AND PAYMENT OF COMPENSATION  
AND REIMBURSEMENT OF EXPENSES OF CAROLYN ROBBINS JURY  
SIMULATIONS, INC., AS EXPERT TO CHAPTER 11 LIQUIDATING TRUSTEE**

**THIS CAUSE** came before the Court on May 30, 2019 at 10:30 a.m., upon the Final Post Confirmation Fee Application for Allowance and Payment of Compensation and Reimbursement of Expenses of Carolyn Robbins Manley and the firm of Carolyn Robbins Jury Simulations, Inc. as Expert to Chapter 11 Liquidating Trustee [ECF No. 3607] (the "***Application***").

The Court, having reviewed the Application, having heard from all parties in interest who had an opportunity to be heard, having taken into consideration 11 U.S.C. § 330 and each of the factors that govern the reasonableness of fees as set forth in *In re First Colonial Corp. of America*, 544 F.2d 1291 (5th Cir. 1977) and *Johnson v. Georgia Highway Express*, 488 F.2d 714 (5th Cir. 1974), having heard the argument of counsel, and based on the record, it is

**ORDERED** that:

1. The Application is **APPROVED**.
2. Carolyn Robbins Jury Simulations, Inc., as expert consultant to the Liquidating Trustee<sup>2</sup>, is awarded compensation in the amount of **\$55,250.00**, (representing 100% of the fees requested) and **\$0.00** (representing 100% of expenses requested) (“*Fee and Cost Award*”).
3. Pursuant to Section 1.76 of the Plan, and as set forth in the Application, the fees awarded herein are subject to the *pro rata* allocation formula. The Fee and Cost Award shall be paid by the particular estate as follows:
