**ORDER AWARDING EIGHTH INTERIM POST CONFIRMATION
FEES AND EXPENSES OF BARRY E. MUKAMAL AS THE LIQUIDATING TRUSTEE**

THIS CAUSE came before the Court on January 28, 2014, at 9:30 a.m., upon the Eighth Interim Post Confirmation Application for Compensation of Barry E. Mukamal, as Liquidating Trustee [ECF No. 2074] (the "*Application*").

The Court, having reviewed the Application, having heard from all parties in interest who had an opportunity to be heard, having taken into consideration 11 U.S.C. § 331 and each of the

factors that govern the reasonableness of fees as set forth in *In re First Colonial Corp. of America*, 544 F.2d 1291 (5th Cir. 1977) and *Johnson v. Georgia Highway Express*, 488 F.2d 714 (5th Cir. 1974), having heard the argument of counsel, and based on the record, it is

ORDERED that:

1. The Application is **APPROVED**.
2. Barry E. Mukamal, Liquidating Trustee², is awarded compensation in the amount of **\$31,370.44** (representing 100% of the fees requested) and **\$1,960.66** (representing 100% of expenses requested) (“*Fee and Cost Award*”).
3. The awarded fees and costs shall be paid by the particular Trust as follows: (a) PBF Liquidating Trust: fees in the amount of **\$6,754.24** and expenses in the amount of **\$352.92** and (b) PBFII Liquidating Trust: fees in the amount of **\$24,616.20** and expenses in the amount of **\$1,607.74**.
4. Pursuant to Section 7.1.11 of the Plan, the Court ratifies payments previously made to the Liquidating Trustee with respect to the Fee and Cost Award.
