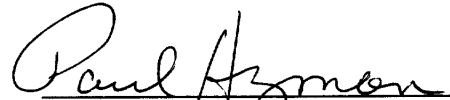

**ORDER GRANTING LIQUIDATING TRUSTEE'S MOTION FOR  
JUDICIAL SETTLEMENT CONFERENCE OR IN  
THE ALTERNATIVE FOR MEDIATION ON 510(b) ISSUES**

THIS CAUSE came before the Court on October 13, 2016 at 9:30 a.m., upon the Motion for Judicial Settlement Conference or in the Alternative for Mediation on 510(b) Issues [ECF No. 3036] (the "*Motion*"). The Court having reviewed the Court file and based upon the reasons set forth on the record which are incorporated here by reference, it is

**ORDERED** as follows:

1. The Motion is **GRANTED**.

2. Barry E. Mukamal, in his capacity as liquidating trustee (the “*Liquidating Trustee*”) for the Palm Beach Finance Partners Liquidating Trust (“*PBF*”) and Palm Beach Finance II Liquidating Trust (“*PBF II*”) may schedule a Judicial Settlement Conference or Mediation and shall file a Notice of same which notice shall set out the name of the Judge or Mediator, the date, time and location of the Judicial Settlement Conference or Mediation and any applicable guidelines of the Judge or Mediator (the “Notice”). The Liquidating Trustee, by and through undersigned counsel, shall cause this Order and the Notice to be posted on the website at <http://www.palmbeachfinanceinfo.com/pleadings.shtml>, under the Tab “Miscellaneous & Administrative Pleadings” and shall serve a copy on all creditors and interested parties listed on the Court’s Matrix in both PBF and PBF II cases.

3. At least 5 days before the scheduled Judicial Settlement Conference or Mediation any party interested in attending the Judicial Settlement Conference or Mediation shall provide written notice to Peter D. Russin, Esq. c/o Lisa Tannenbaum either by email at [ltannenbaum@melandrussin.com](mailto:ltannenbaum@melandrussin.com), by fax at 305-358-1221, or mail at the address listed below, indicating their intention to attend as scheduled so that appropriate arrangements can be made to accommodate all those in attendance.
