**ORDER APPROVING LIQUIDATING TRUSTEE'S MOTION FOR APPROVAL  
OF SETTLEMENT WITH DOUGLAS A. KELLEY, CHAPTER 11 TRUSTEE**

THIS CAUSE came before the Court on July 27, 2012 at 1:00 p.m. upon the Liquidating Trustee's Motion for Approval of Settlement with Douglas A. Kelley, Chapter 11 Trustee [ECF No. 1282] (the "*Motion*") and the objection thereto filed by Nancy Rodman Anguish, Rodman Capital Holdings, Ltd., Beacon Partners, LLC and John Bergman (collectively, the "*Objecting Parties*") [ECF No. 1321] ("*Objection*"). The Court finds that the notice of the proposed compromise and settlement is sufficient to comply with Bankruptcy Rules 9019 and 2002(a)(3), Local Rule 9013-1(D) and any other applicable notice requirement, and accordingly, it is:

**ORDERED** as follows:

1. The Motion is **GRANTED**. The Settlement Agreement between the Petters Trustee and the Liquidating Trustee is **APPROVED**.
2. The Objection is **OVERRULED**.
3. With respect to any mediation relating to the claims asserted against the Objecting Parties by the Liquidating Trustee: (a) the Objecting Parties are not required to disclose any information to the Petters Trustee at any such mediation and (b) the Liquidating Trustee shall not transmit or otherwise share any information provided to him or his professionals by the Objecting Parties absent the written consent of the Objecting Parties (including by email).
